The nomination for the membership of the Board of Directors shall be kept open for at least (10) days from the date of the announcement, and that is in accordance with the requirements of Article (9) of the Board of Directors Resolution No. (3 R.M) of 2020 concerning the Standards of Institutional Discipline and Governance of Public Shareholding Companies.

Any candidate for membership of the Board of Directors has to meet the criteria set forth by the Federal Law No. (22) of 2021 concerning Commercial Companies and the Board of Directors Resolution No. (3 R.M) of 2020 concerning the Standards of Institutional Discipline and Governance of Public Shareholding Companies and Article of Association of the company.
4. To attach to the candidacy application, the documents referred to in Article (10) of the decision of the Board of Directors of the Authority No. (3 R.M) for the year 2020. **Please note that the nomination application will be deemed invalid if the necessary documents are not submitted during the candidacy nomination period for Board of Directors membership.**
5. After the conclusion of the period allocated for nomination, the candidate shall not relinquish his/her nomination to another person.
6. The Company will publish the names of the candidates along with their relevant details on the bulletin board at the Company's headquarters and its website (<https://hayah.com/>) on **Thursday, 01/08/2024**.
7. The Central Bank and the Securities and Commodities Authority will be provided with the list of names of candidates after the end of the nomination period.
